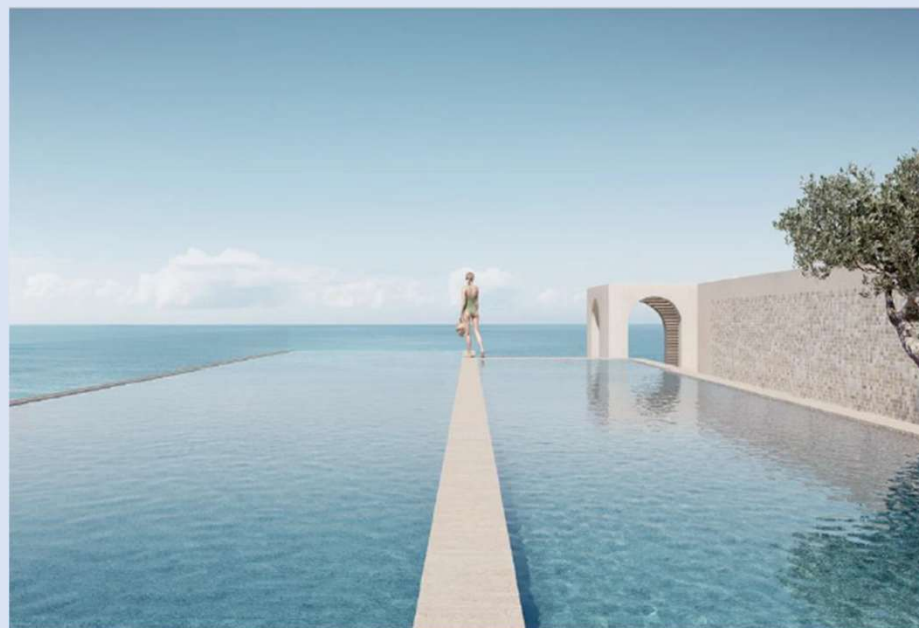

Gavin assesses new mining opportunities including analysis of the business opportunity, mining operating requirements and preparation of feasibility studies.

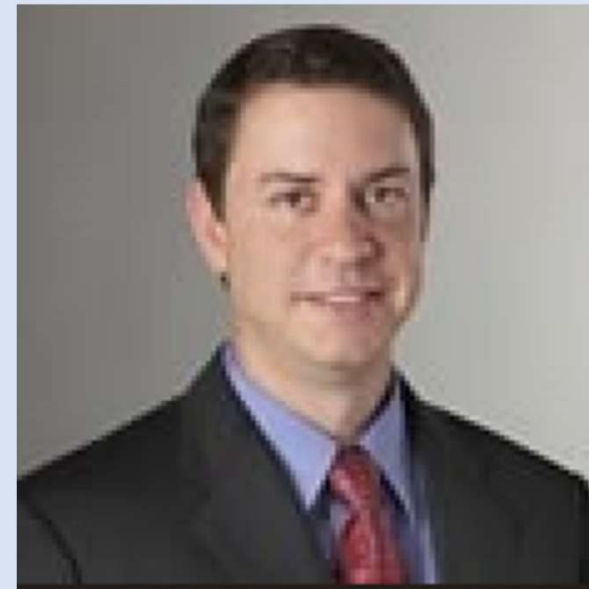
